<p>The principal aim of this study is to explore the meaning of patient centred care (PCC) within diagnostic radiography from the perspective of service users, radiography managers, clinical radiographers, radiography educators and pre-registration student radiographers in order to develop observable and meaningful measures of PCC that might be applied in clinical practice. This study builds on the values and behaviours identified in the Health Education England, Skills for Health & Skill for Care Person-Centred Approaches framework (2017).</p> <p><i>Primary/Secondary research questions</i></p>
